# 2022 ARIZONA FIRST RESPONDER MEMORIAL MOTORCYCLE RALLIES

I would like to take this opportunity to introduce you to the Arizona Fallen Hero Memorial Riders (AZFHMR). In 2018, a group of retired/active duty First Responders and private citizens formed the AZFHMR. During our formation, we agreed to hold annual statewide motorcycle rallies to honor the memories of Arizona First Responders killed in the line of duty. We purposely designed our rallies so everyone is welcome to join us. You do not have to ride a motorcycle to join in our ride routes throughout the state.

In June 2020, the AZFHMR was designated as a 501(c)(3) nonprofit charity and incorporated in Arizona as a nonprofit organization. Our Executive Board and Board of Directors are all volunteers who donate their time and energy to our organization, which allows us to donate 100 % of our program money to charities who support First Responders seriously injured or killed in the line of duty and their families. We do keep a portion of the money raise and it is used as a funding source for the succeeding year rallies.

Again, this year we will be honoring the memories of our fallen heroes with motorcycle rallies in Northern Arizona (September 24<sup>th</sup>), Southern Arizona (October 15<sup>th</sup>) and Central Arizona (November 12<sup>th</sup>). We will conclude each rally with a barbecue and memorial ceremonies for our fallen heroes in each region of the state.

Each year the total of number of riders and volunteers of our events grows, which increases the cost to host all three events. For us to attract more attendees each year, we must keep the entry fees as low as possible; therefore, we seek the support in the form of cash donations, sponsorships, and raffle prizes.
